- a. Approval of revised Board Policy 5707
 - i. Mr. Newington informed the Board of an update to Board Policy 5707: School Wellness Policy. This update adds a new subsection 1.2 to eliminate "lunch shaming." This update is required for schools to receive funds for student meal debt forgiveness as provided by new Section 31k of the State School Aid Act ("SSAA"). Subsection 31k(7) requires eligible school districts to "adopt policies to prevent public identification or stigmatization of pupils who cannot pay for a school meal." The revisions to Policy 5707 were drafted to be consistent with Subsection 31k(7).
