a. **2018 Debt Fund Millage Resolution**

This resolution authorizes the District to levy 7.30 mills for the 2011/2018 debt fund. This resolution must be passed prior to approving the L-4029.

b. **L4029 Approval**

On an annual basis, the L-4029 requires action of the Board of Education to confirm and establish the millage rates to be levied on taxpayers within the school district for the tax year 2018. Millage to be levied December 1, 2018 for the General Fund is 18 mills. Millage to be levied December 1, 2018 for the Debt Retirement Fund is 7.30 mills (1.25 mills – 2011 Debt and 6.05 mills – 2018 Debt).

Mrs. Bagwell **moved**, supported by Mrs. Wechsler, that the board approves the L4029 as presented. **Motion carried 6-0.**
